HOW TO PARTICIPATE

- Registrations open in the month of June each year.
- · Shortlisted students will receive a link to attend the Online Assessment.
- All required information must be provided for your submission to be eligible as mentioned on the registration site.
- The entry limit is one per person overall. Any attempt by anyone to obtain more than the stated number of submissions by using multiple / different accounts, identities, registrations, logins, or any other methods will void your submissions and you may be disqualified. Use of any automated system to participate is prohibited.
- We are not responsible for late, or incomplete submissions. If disputed, submissions will be
 deemed submitted by the "authorized account holder" of the email address, social media account,
 or other method used to enter. The "authorized account holder" is the natural person assigned to
 an email address by internet or online service provider, or other organization responsible for
 assigning email addresses.
