Cisco announces the end-of-sale and end-of-life dates for the Cisco Telepresence Management System. The last day to order the affected product(s) is May 2, 2025. Last Ship Date: App SW,License	The last-possible ship date that can be requested of Cisco and/or its contract manufacturers. Actual ship date is dependent on lead time.	July 31, 2025
