## Overview

### EOL15440

Cisco announces the end-of-sale and end-of-life dates for the Cisco Cellular LTE CAT 6 & CAT 18 Pluggable Interface Modules (PIMs). The last day to order the affected product(s) is January 30, 2025. Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin. Table 1 describes the end-of-life milestones, definitions, and dates for the affected product(s). Table 2 lists the product part numbers affected by this announcement. For customers with active and paid service and support contracts, support will be available under the terms and conditions of customers' service contract.

<b>End-of-Sale Date : HW</b>	The last date to order the product through Cisco point-of-sale mechanisms. The product is no longer for sale after this date.	January 30, 2025
<b>Last Ship Date : HW</b>	The last-possible ship date that can be requested of Cisco and/or its contract manufacturers. Actual ship date is dependent on lead time.	April 30, 2025
<b>End of SW Maintenance Releases Date : HW</b>	The last date that Cisco Engineering may release any final software maintenance releases or bug fixes. After this date, Cisco Engineering will no longer develop, repair, maintain, or test the product software.	January 30, 2026

<b>End of Service Contract Renewal Date : HW</b>	The last date to extend or renew a service contract for the product.	April 27, 2029
