Cisco announces the end-of-sale and end-of-life dates for the Cisco Cellular LTE CAT 6 & CAT 18 Pluggable Interface Modules (UIMs). The last day to order the affected product(s) is February 19, 2025. Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin.
