#### Overview

#### EOL15443

Cisco announces the end-of-sale and end-of-life dates for the Cisco Secure Network Analytics Endpoint License (AnyConnect Network Visibility Module Integration). The last day to order the affected product(s) is September 23, 2024. The last day to renew or add to an existing subscription is December 23, 2024. Customers with active service contracts and subscriptions (as applicable) will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin. Table 1 describes the end-of-life milestones, definitions, and dates for the affected product(s). Table 2 lists the product part numbers affected by this announcement. For customers with active and paid service and support contracts and subscriptions (as applicable), support will be available under the terms and conditions of customers' service contract and subscription.

With Secure Network Analytics Release 7.5.1, the Endpoint license is no longer necessary for the Secure Network Analytics integration with the Network Visibility Module from Cisco Secure Client (AnyConnect). Instead, consumption will count towards a customer's Flow Rate License in order to simplify the entitlement requirements.

End-of-Life Announcement Date	The date the document that announces the end of sale and end of life of a product is distributed to the general public.	August 23, 2024
End-of-Sale Date*	The last date to order the product through Cisco point-of-sale mechanisms. The product is no longer for sale after this date.	September 23, 2024
End of Change/Renewal Date*: Subscription	The last date to Renew or Add to an existing subscription.	December 23, 2024
Last Date of Support**: Subscription	The last date to receive applicable subscription entitlements, service and support for the product as entitled by active subscriptions and service contracts (as applicable) or by warranty terms and conditions. After this date, all subscription and support services for the product are unavailable, and the product becomes obsolete.	September 30, 2027
