Cisco announces the end-of-sale and end-of-life dates for the Cisco Catalyst 9600 Series 48-Port 1G Linecard (C9600-LC-48S). The last day to order the affected product(s) is April 30, 2025. Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin. Last Ship Date: HW	The last-possible ship date that can be requested of Cisco and/or its contract manufacturers. Actual ship date is dependent on lead time.	July 30, 2025
