

# End-of-Sale and End-of-Life Announcement for the Cisco Lumin Power Supply

Cisco announces the end-of-sale and end-of-life dates for the Cisco Lumin Power Supply. The last day to order the affected product(s) is January 26, 2013. Last Ship Date: HW	The last-possible ship date that can be requested of Cisco and/or its contract manufacturers. Actual ship date is dependent on lead time.	April 26, 2013
End of Routine Failure Analysis Date: HW	The last-possible date a routine failure analysis may be performed to determine the cause of hardware product failure or defect.	January 26, 2014
