Introduction

Cisco Smart Licensing is a flexible licensing model that provides you with an easier, faster, and more consistent way to purchase and manage software across the Cisco portfolio and across your organization. And it's secure — you control what users can access. With Smart Licensing you get:

- **Easy Activation:** Smart Licensing establishes a pool of software licenses that can be used across the entire organization — no more PAKs (Product Activation Keys).
- **Unified Management:** My Cisco Entitlements (MCE) provides a complete view into all of your Cisco products and services in an easy-to-use portal, so you always know what you have and what you are using.

- **License Flexibility:** Your software is not node-locked to your hardware, so you can easily use and transfer licenses as needed.

To use Smart Licensing, you must first set up a Smart Account on Cisco Software Central (<https://software.cisco.com/>). For a more detailed overview about Cisco Licensing, go to <https://cisco.com/go/licensingguide>.

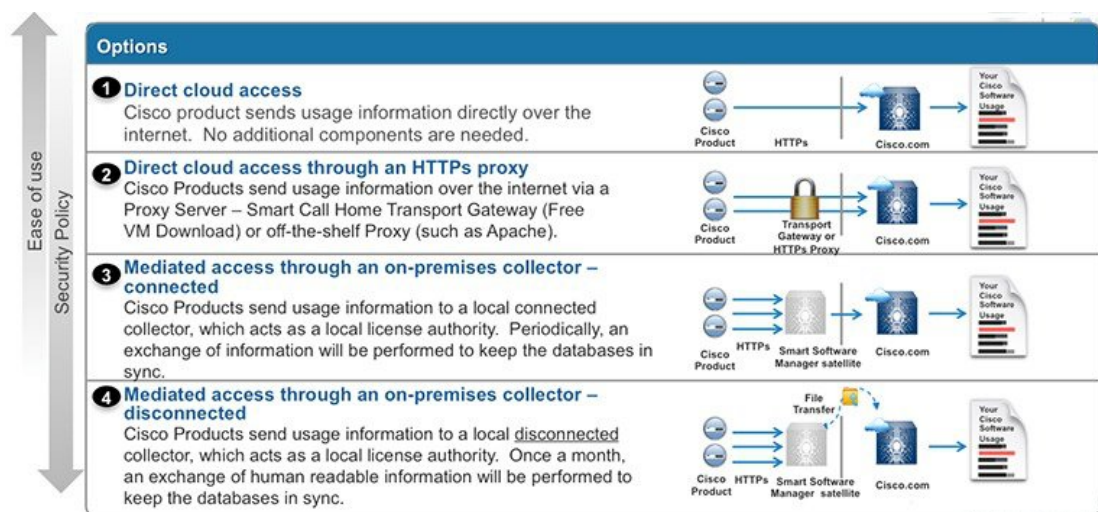
All Smart Software Licensed products, upon configuration and activation with a single token, can self-register, removing the need to go to a website and register product after product with PAKs. Instead of using PAKs or license files, Smart Software Licensing establishes a pool of software licenses or entitlements that can be used across your entire company in a flexible and automated manner. Pooling is particularly helpful with RMAs because it eliminates the need to re-host licenses. You may self manage license deployment throughout your company easily and quickly in the Cisco Smart Software Manager.

Through standard product offers, a standard license platform, and flexible contracts you have a simplified, more productive experience with Cisco software.

Smart Licensing Deployment Modes

Security is a concern for many customers. The options below are listed in an order from easiest to use to most secure.

- The first option is to transfer usage over the Internet to the Cloud server directly from the devices to the cloud via HTTPs.
- The second option is to transfer files directly over the Internet to the Cloud server through an HTTPs proxy, either Smart Call Home Transport Gateway or off the shelf HTTPs proxy such as Apache.
- The third option uses a customer internal collection device called the “Cisco Smart Software Satellite.” The Satellite periodically transmits the information into the cloud using periodic network synchronization. In this instance the only customer system or database transferring information to the cloud is the Satellite. The customer can control what is included in the collector database, which lends itself to higher security.
- The fourth option is to use the Satellite, but to transfer the collected files using manual synchronization at least once a month. In this model the system is not directly connected to the Cloud and an air gap exists between the customers network and the Cisco Cloud.



Smart Account Creation

A Customer Smart Account provides the repository for Smart enabled products and enables Users to manage Cisco Licenses. Once they are deposited, Users can activate licenses, monitor license usage and track Cisco purchases. Your Smart Account can be managed by the Customer directly or a Channel Partner or authorized party. All Customers will need to create a Customer Smart Account to fully utilize the license management features of their smart enabled products. The creation of your Customer Smart Account is a one-time setup activity using the link [Training Resources for Customers, Partners, Distributors, B2B](#)

After the Customer Smart Account Request has been submitted and the Account Domain Identifier has been approved (if edited), the Creator will receive an email notification informing them that they will need to complete the Customer Smart Account setup in Cisco Software Central (CSC).

Cisco Smart Software Manager

Cisco Smart Software Manager (CSSM) is a portal that enables you to manage all your Cisco software licenses from a centralized location. CSSM helps you manage current requirements and review usage trends to plan for future license requirements. You can access the CSSM Web UI at <https://software.cisco.com>. Under the **License** tab, click the **Smart Software Licensing** link.

See the section to know about the different ways in which you can connect to CSSM. In CSSM you can:

- Create, manage, or view virtual accounts.
- Create and manage Product Instance Registration Tokens.
- Transfer licenses between virtual accounts or view licenses.

- Transfer, remove, or view product instances.
- Run reports against your virtual accounts.
- Modify your email notification settings.
- View overall account information.

Cisco Smart Software Manager enables you to manage all of your Cisco Smart software licenses from one centralized website. With Cisco Smart Software Manager, you organize and view your licenses in groups called virtual accounts. You use Cisco Smart Software Manager to transfer the licenses between virtual accounts as needed.

CSSM can be accessed from the Cisco Software Central homepage at software.cisco.com under the Smart Licensing section.

Cisco Smart Software Manager is divided into two main sections: a **Navigation** pane on the top and the main **Work** pane.

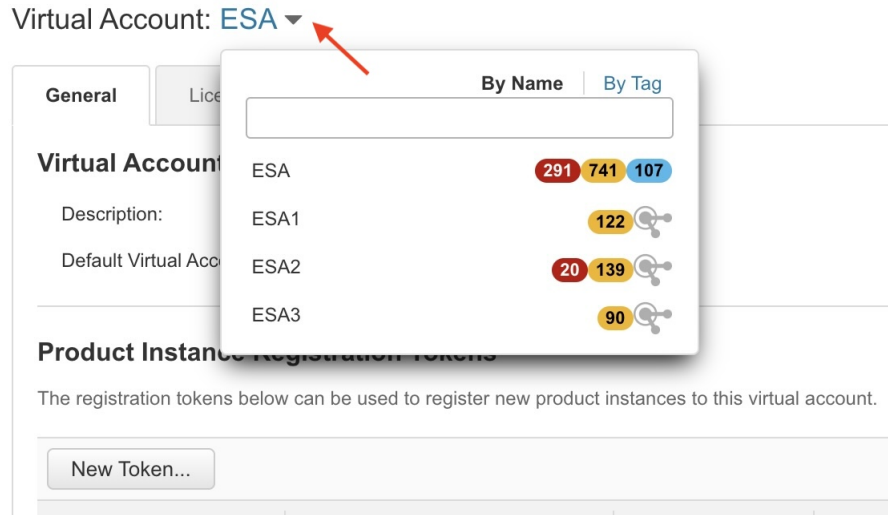

Smart Licensing for Different Users

Smart Software Licensing enables you to manage and monitor email gateway licenses seamlessly. To activate Smart Software licensing, you must register your email gateway with Cisco Smart Software Manager (CSSM) which is the centralized database that maintains the licensing details about all the Cisco products that you

purchase and use. With Smart Licensing, you can register with a single token rather than registering them individually on the website using Product Authorization Keys (PAKs).

Once you register the email gateway, you can track your email gateway licenses and monitor license usage through the CSSM portal. The Smart Agent installed on the email gateway connects the appliance with CSSM and passes the license usage information to the CSSM to track the consumption.



Note If the Smart Account Name in the Smart Licensing account contains unsupported Unicode characters, the email gateway is unable to fetch the Cisco Talos certificate from the Cisco Talos server. You can use the following supported characters: - a-z A-Z 0-9 _ , . @ : & " ' / ; # ? ö ü Ã , () for the Smart Account Name.

License Reservation

You can reserve licenses for features enabled in your email gateway without connecting to the Cisco Smart Software Manager (CSSM) portal. This is mainly beneficial for covered users that deploy the email gateway in a highly secured network environment with no communication to the Internet or external devices.

The feature licenses can be reserved in any one of the following modes:

- **Specific License Reservation (SLR)** – use this mode to reserve licenses for individual features (for example, ‘Mail Handling’) for a given time-period.
- **Permanent License Reservation (PLR)** – use this mode to reserve licenses for all features permanently.

Device Led Conversion

After you register your email gateway with smart licensing, all existing, valid classical licenses are automatically converted to smart licenses using the Device Led Conversion (DLC) process. These converted licenses are updated in the virtual account of the CSSM portal.



Note The DLC process is initiated if the email gateway contains valid feature licenses.



Note After the DLC process is complete, you will not be able to convert the smart licenses to classic licenses. Contact Cisco TAC for assistance.



Note The DLC process takes approximately an hour to complete.

You can view the status of the DLC process – ‘success’ or ‘failed’ in any one of the following ways:

- Device Led Conversion status field under the 'Smart Software Licensing Status' section in the **System Administration > Smart Software Licensing** page of the web interface.
- Conversion Status entry in the `license_smart > status` sub command in the CLI.



Note When the DLC process fails, the system sends a system alert that details the reason for the failure. You need to fix the issue and then use the `license_smart > conversion_start` sub command in the CLI to manually convert the classical licenses to smart licenses.



Note The DLC process is applicable only for classic licenses and not for the SLR or PLR modes of license reservation.

Before you begin

- Make sure that your email gateway has internet connectivity.
- Contact Cisco sales team to create a smart account in Cisco Smart Software Manager portal or install a Cisco Smart Software Manager Satellite on your network.

Note A covered user is the total number of internet-connected employees, subcontractors, and other authorized individuals covered by your email gateway deployment (on-premises or cloud, whichever is applicable.)

For covered users who do not want to directly send the license usage information to the internet, the Smart Software Manager Satellite can be installed on the premises, and it provides a subset of CSSM functionality. Once you download and deploy the satellite application, you can manage licenses locally and securely without sending data to CSSM using the internet. The CSSM Satellite periodically transmits the information to the cloud.



Note If you want to use Smart Software Manager Satellite, use Smart Software Manager Satellite Enhanced Edition 6.1.0.

- The existing covered users of classical licenses (traditional) should migrate their classical licenses to smart licenses.

- The system clock of the email gateway must be in sync with that of the CSSM. Any deviation in the system clock of the email gateway with that of the CSSM, will result in failure of smart licensing operations.



Note If you have internet connectivity and want to connect to the CSSM through a proxy, you must use the same proxy that is configured for the email gateway using **Security Services -> Service updates**.



Note Once Smart Software Licensing is enabled, you cannot revert back to classic licensing. The only way to do so is by completely reverting or resetting the Email Gateway or Email and Web Manager. If you have any questions, contact Cisco TAC.



Note When you configure the proxy on the **Security Services > Service Updates** page, make sure the username you enter does not contain a domain or realm. For example, in the **Username** field, enter only the username instead of DOMAIN\username.



Note For virtual covered users, every time you receive a new PAK file (new or renewal), generate the license file and load the file on the email gateway. After loading the file, you must convert the PAK to Smart Licensing. In Smart Licensing mode, the feature keys section in the license file will be ignored while loading the file and only the certificate information will be used.



Note If you already have a Cisco SecureX account, make sure you first register your email gateway with Cisco SecureX before you enable the Smart Licensing mode on your email gateway.

Perform the following steps to obtain VLN, certificate, and key details and use these details to register your virtual Secure Email Gateway operating in air-gap mode:

- Step 3** Register your virtual Secure Email Gateway operating in air-gap mode with your license reservation. For more information on how to register a virtual Secure Email Gateway with your license reservation, see [Reserving Feature Licenses, on page 18](#).
- Step 4** Enter `updateconfig -> VLNID` subcommand in the CLI.
- Step 5** Paste the copied VLN (in step 2) when you are prompted to enter the VLN.

Token Creation

Token is required to register the product. Registration tokens are stored in the Product Instance Registration Token Table that is associated with your smart account. Once the product is registered, the registration token is no longer necessary and can be revoked and removed from the table. Registration tokens can be valid from 1 to 365 days.

Note New virtual email gateway covered users with no active licenses in Classic Licensing mode will not have the evaluation period even if they enable the Smart Software Licensing feature. Only the existing virtual email gateway covered users with active licenses in Classic Licensing mode will have evaluation period. If new virtual email gateway covered users want to evaluate the smart licensing feature, contact Cisco Sales team to add the evaluation license to the smart account. - (<https://software.cisco.com/> using your login credentials. Navigate to the Virtual Account page of the portal and access the General tab to generate a new token. Copy the Product Instance Registration Token for your email gateway.
- See [Token Creation, on page 13](#) to know about Product Instance Registration Token creation.
- Step 5** Switch back to your email gateway and paste the Product Instance Registration Token.
- Step 6** Click **Register**.

- Step 7** On the Smart Software Licensing page, you can check the Reregister this product instance if it is already registered check box to reregister your email gateway. See [Reregistering the Email Gateway with Smart Cisco Software Manager](#) , on page 17.

Note In a clustered configuration, you can also enable smart software licensing and register all the machines individually with the Cisco Smart Software Manager. In smart licensing cluster mode, you can log into any of the email gateways and configure smart licensing feature. You can log into an email gateway and access other email gateways one by one in the cluster and configure the smart licensing feature without logging off from the first email gateway.
